

This issue of the News & Views is being issued early to comply with our constitution which states that proposed amendments to the constitution must be submitted to the membership 15 days prior to the annual meeting at which the vote is held.

At the last meeting of the Twin City Iris Society the following amendment to the constitution were proposed and will be voted upon at the annual dinner meeting:

Amendment to the constitution as recommended by the Board:

Amendment to Article VII Section 2

The nominating committee shall present a slate of one candidate for each elective office of the society, presentation to be made as provided in the constitution. Nominations may also be made from the floor.

Amendment to Article III Section 4

The immediate past president shall automatically be a member of the board of directors with full voting power of such member.

Amendment to Article X

The Constitution of The Twin City Iris Society may be amended at any meeting provided that such amendment be read to the Society at two (2) previous meetings and that the membership of the Society receive written notice of such at least fifteen (15) days prior to the meeting at which vote is held.

The annual meeting of the Twin City Iris Society will be a dinner meeting to be held at the Rainbow Cafe - between 29th and Lake Street on Hennepin Avenue, Minneapolis. They have a private room and the tickets for a wonderful swiss steak dinner are only \$2.25. The date (I'm sure this time) is Thursday, October 22 - time 6:30 P.M.
